PAINTING PROJECT INFORMATION

Arenas Painting, Inc. has started painting! If you would like to see the new colors, take a stroll over to Elizabeth Court. At the time of this print, just one unit has been painted. It looks great! What is even better is that Arenas Painting repaired both wood and stucco damaged areas prior to painting. Weather permitting, once they start on your unit, it will take 5 to 7 days to complete the work. They will work from 8AM to 4:30PM, Monday thru Friday. You do not need to be home, except when the original only front doors will be painted and left open to dry. Front door painting will be scheduled with you on a Saturday, if you are not available during the week. Arenas Painting will notify you a week prior to starting your unit. To prepare for painting, we are asking you to please remove all items on your front porch/steps. That includes plants, hanging pots, flags, chairs, benches, etc..... The painters will need access to your patio. Please remove pets from the patio. Move all patio furniture, potted and hanging plants, remove old nails, hooks, or screws that you are no longer using. All items need to be moved towards the middle of the patio. They will be covered with plastic. POOL RULES

Summer is here! Please take a few minutes to review the pool rules. Our goal is to keep the pools open all summer long. That can be done if we adhere to these rules. The following are not allowed at any time in the pool area: TRESPASSING, FOOD, SCUBA GEAR, CLIMBING FENCES, GLASSWARE, SWIM FINS, DIVING INTO THE POOL, LOUD MUSIC, SURF-BOARDS, FRISBEES, CUT-OFFS OF ANY KIND, BIKES, SKATEBOARDS, SCOOTERS, HORSEPLAY, PATIO FURNITURE IN THE POOL, BALLOONS, SMOKING, PUSHING, RUNNING, BOISTEROUS OR OBSCENE LANGUAGE, ANIMALS, EXCESSIVE NOISE, STYROFOAM OBJECTS, METAL CANS OR OBJECTS, OIL-BASED LOTIONS. Gates must remain locked and shut at all times. Never give your key to anyone at the gate. Maximum of 3 guests allowed at a time. There are NO lifeguards on duty. The buddy system is to be used at all times. All children under 14 must be accompanied by an adult 18 years of age or older. This is a STATE LAW. Infants and toddlers must wear a plastic swim diaper that has an elastic waist with elastic around both legs.
