Never give your key to anyone. Maximum of 3 guests are allowed at a time. THERE ARE NO LIFEGUARDS ON DUTY. THE BUDDY SYSTEM IS TO BE USED AT ALL TIMES.

ALL CHILDREN UNDER 14
MUST BE ACCOMPANIED BY
AN ADULT 18 YEARS OF AGE
OR OLDER. THIS IS A STATE
LAW. Infants and toddlers must
wear a plastic swim diaper that
has an elastic waist with elastic
around both legs.
